The Manufacturer here with declares that the cited products comply with Regulation (EC) No. 1907/2006 concerning the Registration, Evaluation, Authorization, and Restriction of Chemicals (REACH) and its amendments up to (EU) 2016/26, (EU)2017/227, (Eu)2018/35. Substances above 1000 and 100 tons per year were registered on the 1st December 2010 and 1st June 2013 respectively. Products that are mixtures will not need to be registered; however, the substances that are contained within the mixture may need to be registered, except for exempt substances under REACH according to Annex V, Article 2 (2) (7) b. Minerals like natural calcium carbonate, talc, dolomite, and clay are exempted unless they are not chemically modified according to this annex clause 7
